At the outset the chairman welcomed all the participants and gave a brief introduction of agenda of the pre-bid meeting.

The queries raised by the individuals/representative of firms were discussed and the following clarification was issued:-

- The cost of the tender document shall be 5000/- & EMD shall be 50,000/- for all the tenders of street sweeping.
- Removal of dead animals shall be in the scope of tenders for "Street Sweeping". Consequently the clause No. (XV) of the scope of work shall be omitted from the tender for "Door to Door collection".
- Annual turnover for the door to door collection tender shall be 1 crore instead of Rs. 50 lakhs. Annual turnover for tender of street sweeping shall remain the same i.e. 50 lakhs.
- The vehicles used for sanitation work shall be covered and separate compartments for wet and dry waste shall be made as per SWM guidelines.
- Each bidder individual /firm /Corporation /Company can participate in any number of bids. However, maximum 2 works of each package (street sweeping & Door to Door collection) will be awarded .Clause No. 3.6.6 & 3.6.7 of (financial proposal) shall be invoked in case an individual /firm /corporation/company quotes L-1 rates in more than two works of a single package (street sweeping & door to door collection).
- In the absence of ESI hospital facility in Dharamshala, the successful bidder has to enroll the workman/supervisor/driver etc. in group Insurance/workmen compensation Act etc.
- Note-2 in the Appendix –X in the tender for "Door to Door Collection" stands omitted.
 No JCB machine is required by DMC.
- The period of agreement shall be initially for a period of 3 years, which shall be extendable up to 5 years, if DMC is satisfied with working of successful tenderer.

• All other terms & conditions mentioned in R&P shall remain the same.
