#### Definitions:-


**J-1) Household:-** Household means and constitute one family having a separate kitchen however where one family or members of the family are having two separate kitchens running then two (02) household units will be counted for the purpose of door to door collection of garbage charges.

**R-1) Shop :-** Shop means and constitute any vendor, kiosk, spread tin shed, open vending or any kind of shop which generates some revenue or involved in any kind of commercial activity for the purpose of door to door collection of garbage charges.
